Council on the Ageing (WA) Inc. [COTA (WA)] was established in 1959 as the peak body representing the interests of people aged over 50 in Western Australia.

As a member of the COTA Federation, COTA (WA) collaborates with the other State COTAs as well as COTA Australia to advocate and influence (on a State and National level) on matters of importance to older Australians.

A key way in which COTA (WA) achieves this is by representing the interests of Western Australian seniors on many advisory committees and reference groups. Our advocacy work includes collaboration with sector partners on issues such as health, elder abuse, affordable housing, mature age employment and supporting vulnerable cohorts including Aboriginal and Torres Strait Islanders, CaLD and LGBTI persons.

Currently there are around 908,000 Western Australians over the age of 50 and this number will continue to increase for the next thirty years. Making up one-third of our population, this cohort represents a large proportion of:

- Volunteers

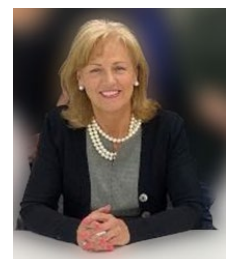

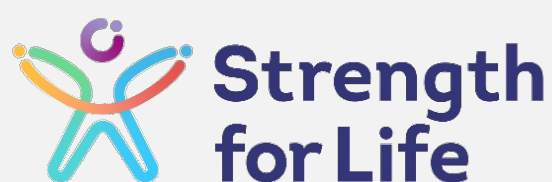
