## **Chair Report**

As the incoming Chair, I would like to acknowledge the outgoing Chair, Gerri Clay, and Directors (and all former Presidents) Bettine Heathcote AM, Judy Hogben AM and Ron Regan, and thank you for your unwavering commitment to the mission and vision of COTA (WA).

The growing importance of the role of COTA (WA) in representing the interests of all seniors, has been publicly acknowledged through its recognition as the Seniors Peak Body. A key outcome of this



recognition has been a continuing closer alignment with both government and sector agencies, particularly through the establishment of the Seniors Sector Partnership, Chaired by COTA (WA). This influential group brings the sector together to build the capacity of its members to support and improve the lives of older Western Australians through the exchange of information; leveraging collective knowledge and capabilities; collectively responding to Government policies and decisions, and engaging in joint advocacy and funding applications, where appropriate.

Another important initiative of COTA (WA) was the establishment of the Positive Ageing Alliance, which brings together business leaders and prominent and influential people across many sectors and industries in Western Australia. Chaired by COTA (WA) Board Director Emeritus Professor Gary Martin, four meetings were held at Government House and hosted by our Patron, The Honourable Kim Beazley AC to discuss how non-government entities are reacting to, or addressing, the challenges and issues of an ageing population. The Board thanks Professor Gary Martin for his role in this area.

It is pleasing that the WA State Government is continuing its consultation for the development of the inaugural WA Seniors Strategy. Seniors must be given a higher priority if they are to age well and in a place of their choosing and to this end, one of the key proposals of COTA (WA) in its submission to the Government, is to appoint a 'Commissioner for Seniors'. We believe that this role will ensure strong advocacy and ultimately, a higher profile for seniors through this independent, prominent and influential representative, whose role will be to advocate within all levels of government, the private sector and other appropriate platforms. It is anticipated that should such an appointment be approved, the Commissioner for Seniors will establish a public presence through participation in all forms of media, including social media. It is worth noting that currently Victoria is the only State in Australia to have a Commissioner for Seniors in place.

The importance of older people being able to remain engaged and connected to their families, friends and communities and staying healthy and well, are the primary drivers of all our policy and advocacy work. In this capacity, we bring over 60 years of experience and expertise to our activities, which is being increasingly recognised by government and non-government agencies alike.

On behalf of COTA (WA), it is my privilege to thank the outgoing Western Australian Governor, The Honourable Kim Beazley AC, for his commitment to older Western Australians through his support as Patron of COTA (WA). We are particularly grateful to him for his demonstration of this commitment in hosting the Positive Ageing Alliance in its meetings.

I would also like to thank Adam Levine and the team from K&L Gates (Global Counsel across five Continents) who provide pro bono support and advice, to ensure we continue to demonstrate good governance.

I thank my fellow Directors and COTA (WA) staff for their support over a difficult period in which we contended with a shrinking financial environment and an expanding advocacy environment. COTA (WA) has managed this environment with recognised success, and we look forward to continuing success in our proposed initiatives and roles for 2023.

## **Chief Executive Officer Report**

Learning to adapt and live well in a post pandemic world has been the focus for everyone in the past twelve months. And while older people are resilient, the feedback from them has identified that they are frustrated with navigating multiple pathways to find information or services for their needs as they age. Put simply, they want a one-stop-shop to enable them to find the information they need without having to go down multiple pathways, often with no tangible results. This is something that COTA (WA) has been advocating for many years and consequently we made this one of the key proposals in our submission to the WA Seniors Strategy 2023-33.



As the State Government appointed Seniors Peak, COTA (WA) is cognisant of the work that needs to be undertaken, particularly around some of the key areas identified by older people including elder abuse, the great digital divide, mature age employment and the vulnerable and disadvantaged cohorts such as First Nations People and the CaLD and LGBTIQ+ Communities.

To support the sector in responding to elder abuse, we held an online forum which was recorded for use as an ongoing resource. Our thanks to our collaborative partner, Northern Suburbs Community Legal Centre and our speakers from WA Police, WA Health Department, Older People's Rights Service and MyVista Aged Care.

Over the last twelve months, we have built on our leadership role in the seniors' sector and increased our advocacy on behalf of older Western Australians.

A tangible outcome of this advocacy is the production of our Seniors' Guides. The COTA (WA) Seniors Guides continue to be a valuable resource with four (4) guides in circulation (At Home Guide, Goodbye Guide, Understanding the Mistreatment of Older People and Interruptions to Daily Living) and we are proud to have translated the Interruptions to Daily Living Guide into four (4) languages (Simplified Chinese, Polish, Greek and Italian). This Guide was developed to support seniors as the WA borders were opened and many people chose to self-isolate. The latest Guides were developed with a grant from Lotterywest, and we acknowledge their support for this important initiative.

Digital literacy, cyber security and scams are some of the biggest challenges facing seniors so we partnered with Bankwest and Department of Communities to deliver the Let's Talk Scams event at the Perth Convention Exhibition Centre. Our thanks to our Patron, The Honourable Kim Beazley AC for being our guest speaker and the inimitable Dr David Cook from Edith Cowan University for his informative and always entertaining presentation. To ensure we reached as many people as possible, this event was live streamed and recorded for distribution to regional centres.

Our role as the sector leader for seniors has been further demonstrated through collaboration on a number of initiatives including a letter to the Premier in response to seniors' frustration in adopting the ServiceWA app, the translation of the Seniors Guides to multiple languages, delivery COTA (WA) 2021-2022 COTA (WA) Annual Report Page 5 of 33 of seniors events and forums, consultation for the State Government's WA Seniors Strategy and regular meetings with the Minister for Seniors and Ageing, The Hon. Don Punch MLA.

Although we are generally not a service provider, two programs currently offered are extremely successful. Our Strength for Life<sup>™</sup> program remains as popular as ever with seniors, with around 5,000 participants across Western Australia. The program is delivered in 58 locations (including 14 Regional).

The Aged Care System Navigation trial program continues to gather momentum as older people and their family or carers use our service to support them in understanding and accessing aged care services. We are hopeful that our recent application to run this program on a more permanent basis is successful.

One of the highlights of the year for us is the WA Seniors Awards which COTA (WA) delivers on behalf of the WA State Government. It is inspiring and humbling to hear the stories of people who have dedicated many, many years of their life to making their community a better place and for the most part, they seek no recognition or reward for their service.

In addition to our work with the sector and directly with seniors, we also contribute to many committees and panels, as well as undertaking requests to review draft reports and proposed policy documents.

With extremely limited resources, COTA (WA) punches well above its weight and our success is due to the dedication of a very committed team and some outstanding volunteers and McCusker Interns. People are always surprised to learn that we operate with only 4.8 FTE. As always, our success is built on our relationships with stakeholders including State and Local Governments, the sector, universities and other sponsors and supporters.

Overall, we have had a successful year in terms of delivering on our contracts and addressing the key priorities for seniors. However, our biggest challenge remains that of long-term sustainable funding. To partially address this issue, this year we introduced the COTA (WA) Supporters Program and we acknowledge those organisations who have shown their support for us and for the work we do to advocate for a better future for seniors in Western Australia.

As is the case with other organisations in the sector, we look forward to the release of the new 10-year WA Seniors Strategy and to working closely with the State Government and the seniors sector on the implementation phase.

I feel that this has been a year of unprecedented collaboration and I acknowledge the Department of Communities and all of the organisations that make up the Seniors Sector Partnership. Working together, we have been more effective in addressing the needs of seniors in the community.

And finally, I express my gratitude to the Board and the multi-skilled team of staff and volunteers who have contributed to our success during this financial year.

### WA Seniors Strategy 2022-2032

COTA (WA) contributed to the consultation by the State Government for the WA Seniors Strategy.

There are now multiple generations of older Western Australians who fall into the category of 'seniors', each with different challenges, attributes, issues and priorities.

With an ageing population and people living longer than ever before, there is an increasing number of adult children (baby boomers), many of whom are themselves seniors, who are involved in the care of ageing parents.

The challenge for the State Government in developing the WA Seniors Strategy is to ensure that seniors' sector organisations are adequately funded to meet the broad range of community needs, with no older Western Australians left behind or disadvantaged.





COTA (WA) appreciates the opportunity to have input into the WA Seniors Strategy and encourages the government to engage the Seniors Sector Partnership at every stage of the process to support a strategy which is comprehensive, realistic and achievable.

COTA (WA) proposed the appointment of a 'Commissioner for Seniors' to headline the 2022-2032 Seniors Strategy and to demonstrate the State Government's commitment to escalate seniors' issues in its priority areas.




The Hon. Kim Beazley AC, Governor of Western Australia provided the opening address.

## Initiatives

## 2021-2022 Seniors Information Guides

### **Understanding the Mistreatment of Older People Guide**

Building on the popularity of the previous Seniors Guides which were developed by COTA (WA) Chief Policy Officer Chris Jeffery, a further series of guides was released.

To support older people in the community to recognise or respond to elder abuse, a new guide titled **Understanding the Mistreatment of Older People** was developed. The guide was launched by Minister Don Punch during the week of World Elder Abuse Awareness Day.

COTA (WA) acknowledges the support of The Hon Don Punch MLA, Minister for Disability Services; Fisheries; Small Business; Seniors and Ageing who launched the Guide on 14 June 2022, the Department of Communities WA and the Northern Suburbs Community Legal Centres (Older Peoples Rights Service) and Lotterywest who provided the grant to produce this Guide.





## **Interruptions to Daily Living Guide**

Council on the Ageing WA launched a new resource for seniors, the **Interruptions to Daily Living** Guide, in collaboration with sector and peak body organisations who support older Western Australians, and was released to coincide with the opening of Western Australia's borders in March 2022.

This Guide was the first of our publications to be translated and is now available in five (5) languages: English, Simplified Chinese, Polish, Italian and Greek.

COTA (WA) acknowledges the support of Chung Wah Community Care, Umbrella Multicultural Community Care and the Department of Communities WA in the translation of these Guides.



## **The Positive Ageing Alliance**

**The Positive Ageing Alliance** was formed in March 2021 to increase awareness of seniors' issues to a broader range of sectors including sport, culture and the arts, accounting and finance, travel and tourism, aged care, media and communications, legal, academia, health and other community services. There are 25 members of the Alliance, including Department of Communities, which was chaired by former COTA (WA) Board Director Professor Gary Martin. Western Australian Governor, The Hon. Kim Beazley AC was the Patron of COTA (WA) and hosted the Positive Ageing Alliance meetings at Government House.

## Each of the four meetings discussed a key issue: Elder Abuse, The Great Digital Divide, Vulnerable Cohorts and Mature Age Employment.

The primary purpose of the Positive Ageing Alliance (PAA) is to explore some of the key challenges facing older Western Australians, to seek feedback on how well each particular issue is understood by the broader community sectors, and to suggest specific measures and policy changes to rectify the identified short comings.

In undertaking this role, the PAA attempts to promulgate messages about positive ageing with a view to changing attitudes to ageing and older people by focusing on the positive attributes of ageing rather than the negative perspective often portrayed by mainstream media.

The major outcome of this approach is intended to raise community awareness of the contribution older people can, and do, make to society.

COTA (WA) provided a 'Report on the Inaugural Year 2021-2022' to The Hon Don Punch MLA, Minister for Disability Services; Small Business; Seniors and Ageing.

### **The Seniors Sector Partnership**

**The Seniors Sector Partnership (SSP)** was formed in December 2020 to create cohesion between organisations who have a focus on delivering (funded) services or activities for seniors. This initiative is part of the Vulnerable Seniors Peak agreement, funded by Department of Communities and brings together 30 organisations across state and local government, peak bodies and community service providers.

## **COTA (WA) Listening Post 'Chung Wah Community Care'**

#### Seniors 'Speaking up' in WA

\*Translated excerpt from the article in local newspaper Australian Chinese Times (ACTimes).

On Tuesday 12 October 2021, Chung Wah Community Care (Chung Wah CC) and five community hub seniors participated in the 'Listening Posts' project organised by the Council on the Ageing WA. This project aims to interview 500 older persons from diverse backgrounds, hearing each participant's thoughts, opinions and concerns in an informal setting. The information gathered during the interviews will be anonymously presented to the



government agencies for aged care services, detailing the needs and various challenges our older Western Australians are currently facing.

Our Chung Wah CC seniors spoke candidly during the Listening Posts project as they shared their thoughts on health, housing, social environment, technology and finance. However, they were all quite taken by the last hypothetical question from the organiser, "If you had ten minutes to talk to the WA Premier or the local mayor, what advice would you like to offer to help the older Western Australians?" Our participating seniors thought carefully, and each offered their valuable views.

The Listening Post initiative was unable to be completed during this period due to the opening of the WA borders and the resulting anxiety among older people in the community. The Listening Posts would be resumed later in 2022.

#### **Seniors and Carers Expo**

In October 2021, the City of Rockingham held a Seniors and Carers Expo at the Mike Barnett Sports Complex in Rockingham.

Midland Gate Community Hub: In March 2022, COTA (WA) Aged Care Navigator, Margaret Fisher set-up an information booth, in the Midland Gate Community Hub to let seniors in the suburb of Midland know what services are available to them.





Have A Go Day 2021: In November 2021 during Seniors Week, COTA (WA) had a booth at the Have A Go Day Seniors Event run by the Seniors Recreation Council of WA where we were able to engage with hundreds of seniors and distribute information This event is always fun and is an important date in our annual calendar.

**City of Armadale Aged Care System Navigation 'Seniors Information Session'** was presented in August 2021 for seniors living within the City of Armadale.





**Multicultural Seniors Festival:** In November 2021 during Seniors Week, Umbrella Multicultural Community Care held a Multicultural Seniors Festival.



**Midland Sunshine Club Seniors Expo:** In November 2021 during Seniors Week, The Midland Sunshine Club held its very first Seniors Expo. The event was for seniors to find out a range of products and services available for seniors in the City of Swan area.

Southwest Men's Shed Conference: In March 2022, the Southwest Men's Shed held a conference in the regional town of

Brunswick at the Brunswick Junction. COTA (WA) Chief Policy Officer Chris Jeffrey did a presentation on 'How to Age Disgracefully'.

**Positive Ageing Expo:** In June 2022, The City of Fremantle joined with the City of Melville to hold a 'Positive Ageing Expo' at the Walyalup Civic Centre.

**Tech Savvy Event:** In June 2022, Stay on Your Feet and The Seniors Recreation Council held a Tech Savvy Event at the Loftus Recreation Centre.

Seniors Lifestyle Connection Point: In June 2022, the City of Joondalup held a 'Seniors Lifestyle Connection Point' at the Westfield Whitfords Shopping Centre.

#### Kalamunda National Seniors Group Aged Care Navigation Session

COTA (WA) enjoyed the hospitality of the Kalamunda National Seniors Group with over 100 attendees to present an overview of COTA (WA) and to provide free and independent information for Seniors about navigating the Aged Care system.

## **Projects and Programs**

#### Strength for Life<sup>™</sup>

Strength for Life<sup>™</sup> is a strength training program designed to improve and extend the quality of life for people over 50. Over 15 years, this program has helped over 5,436 older people per year in Western Australia.

Under a contract agreement, COTA (WA) licenses accredited organisations (such as physiotherapists, exercise physiologists and fitness professionals) to provide this program, which is an evidence based, falls prevention program specifically designed for seniors.

As of 30 June 2022, there were 56 providers, including 14 regional locations, delivering the program in Western Australia. During the year, 9 new providers were endorsed and 27 new instructors trained, with 40 Instructors attending refresher Courses.

COTA (WA) attended and delivered 12 Expos and Strength for Life presentations to promote the program.

#### Mall Walking



The Mall Walking Program has been operated by COTA (WA) since 2014. In addition to the physical exercise component, this initiative is popular with seniors due to the social activity, with more than 500 people engaged in mall walking activity across participating shopping centres.

Mall Walking is led by a team of trained Mall Walking leaders who volunteer their time to ensure the ongoing success of

the program. We acknowledge the enormous amount of time and effort the Mall Walk Leaders put in to ensuring our participants are registered, safe and welcomed.



COVID restrictions had a significant impact on the Mall Walking program in this year and decisions were made by the participating shopping centres to cease their program sponsorship with COTA WA in June 2022.

#### **Aged Care System Navigation**

This project is part of a federally funded national trial to assist the community to navigate the aged care system until the point of service commencement.

COTA (WA) collaborated with local governments, community groups and seniors clubs to host seniors information sessions which include a presentation, Q&A and morning tea.

The program was delivered by Margaret Fisher, COTA (WA) Aged Care Navigator and expert volunteers and was promoted through our community engagement channels, including Facebook and newsletters and events such as the Care & Ageing Well Expo and Have a Go Day.

Margaret said, "I have enjoyed working across a full spectrum of navigation cases and working with people from all situations and backgrounds. The requests range from providing some basic information about My Aged



Care to helping clients find a package provider and on to navigating the journey to transfer from one residential aged care facility to another. I really enjoy the variety of work and feel I am constantly learning more about aged care. Lack of service availability is a very real challenge and it is incredibly difficult to explain to a Carer that there is not residential respite available so they can have a well-deserved break. Keeping up with demand for navigation services, has been another challenge."

Margaret has supported over 400 clients since August 2021.
