Council on the Ageing (WA) Inc. [COTA (WA)] was established in 1959 as the peak body representing the interests of people aged over 50 in Western Australia.

As a member of the COTA Federation, COTA (WA) collaborates with the other State COTAs as well as COTA Australia to advocate and influence (on a State and National level) on matters of importance to older Australians.

A key way in which COTA (WA) achieves this is by representing the interests of Western Australian seniors on many advisory committees and reference groups. Our advocacy work includes collaboration with sector partners on issues such as health, elder abuse, affordable housing, mature age employment and supporting vulnerable cohorts including First Nations people and CaLD and LGBTI people.
